GATHERING CHARGE - Where gathering is performed by CITGO Pipeline Company at point of origin an additional charge of fifty four and fifty hundredths cents [I] (54.50¢) per barrel of forty-two 42 U.S. gallons will be made in addition to the transportation rate named herein.

STORAGE - Storage of crude petroleum will be provided by CITGO Pipeline Company at Sour Lake, Hardin County, Texas, for delivery to another carrier's system at a charge of thirteen and seventy four hundredths cents [I] ($13.74 \, \phi$) per barrel per month of forty-two (42) U.S. gallons.

PUMPING CHARGE - For delivery to connecting pipelines other than those of CITGO Pipeline Company when pumping service is performed, a charge of <u>eight and forty seven</u> hundredths cents [I] (8.47¢) per barrel of forty-two 42 U.S. gallons will be made on all crude petroleum.

ROUTE - Via CITGO Pipeline Company.

Reversal of Pipeline - The normal direction of the pipeline flow is from Sour Lake to Pecan Grove. For transportation from Pecan Grove to Sour Lake, the pipeline must be reversed and the current linefill will be backed out of the line. Reversal requests should be made at the normal time of nominations for the month. Shipper will supply pumping at Pecan Grove equal to 5 MBPH. Shipper requesting this line reversal shall supply, in addition to the nominated barrels, line displacement barrels and shall then receive the line displacement barrels back at Pecan Grove. All barrels are subject to the normal transportation charge. The result will be charges equal to the transportation rate multiplied by the current linefill (approximately 125,000 barrels) which will be charged when Crude Petroleum is backed out of the line at Sour Lake. The same amount will again be charged when the line displacement barrels are delivered back to Pecan Grove. The result will be a charge of [I] \$ 104.84 x 125,000 x 2 or approximately \$ 262,100 in addition to normal transportation charges on the barrels being delivered from Pecan Grove to Sour Lake.
